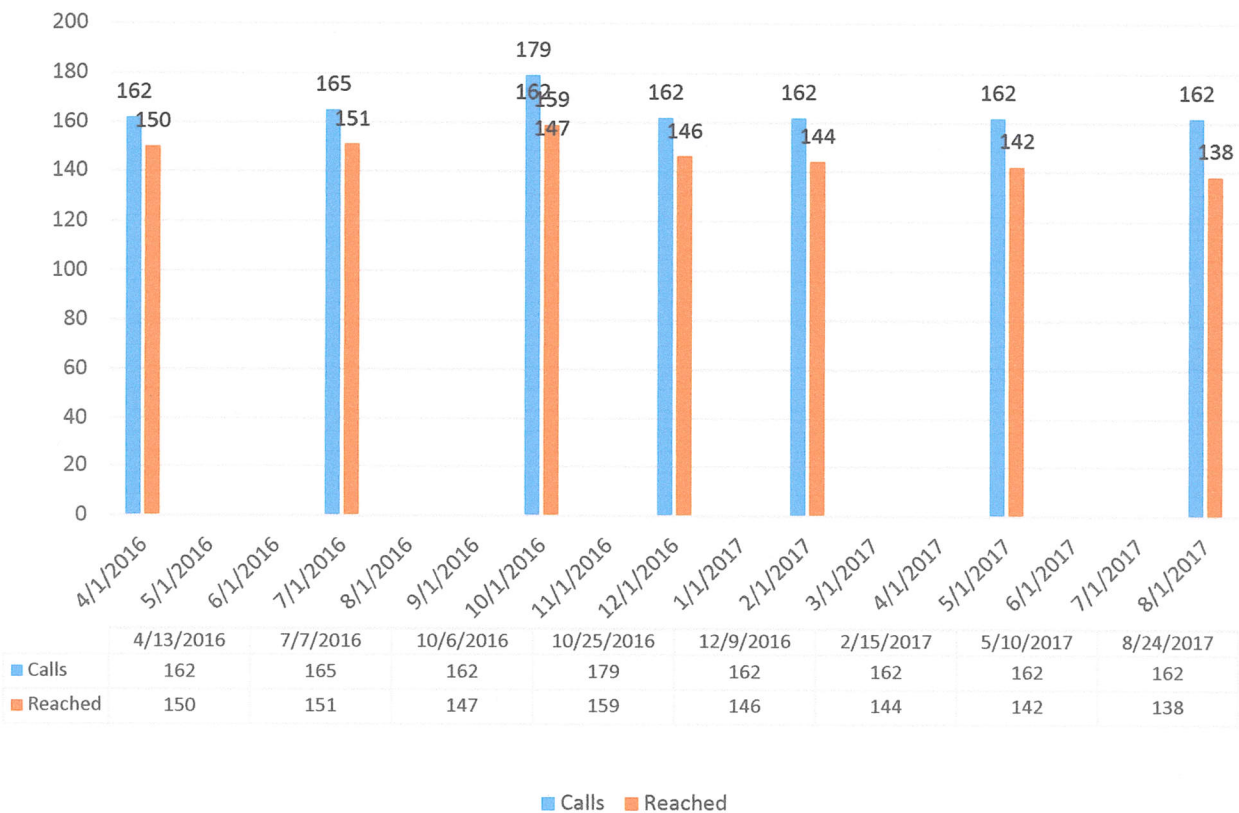

Regarding: One Call Notification Recap:

- A notification drill was performed on 8-24-2017 in response to a call from Ergon. The following scenario was given: **158 gallons of crude oil has spilled during a barge transfer into the Ohio River. Ergon is located at the 47.2-mile marker on the Ohio River.**
- TRPRC members were instructed to respond on the website if possible with equipment available and an eta to Ergon’s location. Members that could not respond via website were instructed to call (304)3746923.
- 86% of calls sent out were received
- Subgroup 13 should be used when one call notification drills are being performed
